United Commercial Bank (UCB), once one of the strongest private banks, is now in a major financial crisis. Non-performing loans have exceeded Tk 10,000 crore, and the capital deficit has reached about Tk 1,300 crore. To partially meet this deficit, the bank has taken the initiative to raise Tk 775 crore from the stock market. However, a big challenge has arisen at the beginning of that initiative. While the price of each UCB share in the market is Tk 9.10, the right shares will be sold to existing shareholders at Tk 10. As a result, questions have arisen in the market about how successful this share issue will be.
